These costs are projected based on current figures, and any inflationary costs or economic growth trends would require the expertise of economist. ## Types of Files:

Life care planning was traditionally used by attorneys to provide a realistic basis for awarding damages in personal injury or liability cases. Today, life care planning is used in many other areas by the insurance industry to set reserves and manage claims in the most cost-effective manner. Examples of cases that would benefit from life care planning are:

- + Catastrophic injury such as brain or spinal cord injury
- + Amputations or specific loss cases
- + Catastrophic pediatric cases
- + Medical malpractice cases
- + Personal injury cases

- + Structured settlements
- + Evaluation of opposing party's life care plan or settlement proposal
